Cancellation Clause

If a cancellation by Max Strom due to insufficient registrations or due to circumstances beyond our control were to occur, your registration fee would be refunded in full.

Right of withdrawal/cancellation policy retreat by participant

If you request a cancellation that occurs within 14 days after the date of purchase and no less than 60 days before the start of the retreat in question, you will be reimbursed the full amount of your tuition minus any incurred bank charges and an administration fee of €100.

If you request cancellation between 59 and 30 days before the start of the retreat, Max Strom will reimburse 50% of your tuition, minus any incurred bank charges and an administration fee of 100 euro.

If you request cancellation between 29 and 14 days before the start of the retreat, Max Strom will reimburse 25% of your tuition, minus any incurred bank charges and a cancellation fee of €100 euro.

If you request cancellation under 14 days before the start of the event, you forfeit the entire tuition, and no refunds will be issued.

Your cancellation must be in writing and sent to hello@maxstrom.com. Once a partial or full reimbursement has been agreed upon it may take up to 7 days for the transaction to be processed.

COVID/pandemic/uneforeseen world events

- If the retreat has to be postponed based on border closures, a credit for the guests will be issued. If the retreat happens as scheduled, but a guest decides not to attend based on any other reason than a country's border closure, then the regular cancellation policy stated above will be maintained.
- All attendees will agree to adhere to any regulations in place of the location where the retreat is held. All travel mandatory requirements will be followed as required by law and while on retreat, guests agree to any local regulations in place.
